1. These terms apply whenever you authorise Move Dynamics Pty Ltd (Move Dynamics) to charge your credit card for payment of any monies to Move Dynamics.
2. You authorise Move Dynamics to charge your credit card for payment of either a singular payment or ongoing payments for storage accounts, noting that a credit card surcharge may apply to your transaction, on the basis of the details of any credit card request completed by you or on your behalf.
3. In the event that the processing of any payment is declined or fails for any reason, you agree that the provision of services by or on behalf of Move Dynamics may be terminated or suspended by Move Dynamics without notice, until alternate payment arrangements are made. You release and waive any claim for loss or damage howsoever arising from or in connection with any such suspension by Move Dynamics.
4. If the provision of any services the subject of any payment to be made in accordance with these terms are being provided by or on behalf of Move Dynamics under an agreement with another person (e.g. your employer), then the provision of those services is at all times subject to the terms of that agreement, which can be obtained by you from the person who entered into the agreement (e.g. your employer) or from Move Dynamics, upon request.
5. If the provision of any services the subject of any payment to be made in accordance with these terms is not pursuant to an agreement referred to in clause 2, then the provision of services by or on behalf of Move Dynamics is at all times subject to Grace Removals Group's General Conditions of Removal and Storage, which are available upon request.
6. Move Dynamics may amend or vary these credit card terms at any time. If this occurs, Move Dynamics will provide you with 14 days' advance notice in writing prior to the changes taking effect. During that period, if you do not wish to accept those amended or varied terms, you may terminate your authority. If you terminate your authority, you agree that the provision of services by or on behalf of Move Dynamics may be terminated or suspended by Move Dynamics without notice, until alternate payment arrangements are made. You release and waive any claim for loss or damage howsoever arising from or in connection with any such suspension by Move Dynamics.
7. You certify and warrant that you are the authorised user of any credit card provided by you.
8. You agree to allow Move Dynamics to pre-authorise your credit card for the amount of any payments that you have authorised. Pre-authorised cards may be held as security for any Cancellation Fee.
9. You warrant that you will not dispute any payments made under or in accordance with these terms and any authority provided by you.
10. Where the collection, retention and use of your personal information is subject to any mandatory privacy laws of any Australian jurisdiction, your personal information will be collected, held and used by Move Dynamics in accordance with those laws.
11. You agree that your information will be saved to file for future transactions on your account.
12. Move Dynamics does not accept any responsibility for loss or damage of any nature whatsoever and howsoever arising from any unauthorised access to your information, unless caused by the wilful conduct of Move Dynamics. You hereby release and waive any such claims against Move Dynamics.
13. Your authority for us to charge your credit card will remain in effect until cancelled. You may cancel your authority at any time prior to the provision of relevant services by Move Dynamics by contacting us and providing us with at least 7 days' notice in writing.
